The Welcome Back Initiative

- San Francisco Welcome Back Center opened in 2001
- The mission to connect the un-tapped pool of immigrant health professionals residing in California with the need for a health workforce that better reflected the linguistic and cultural diversity of the state
- Nine centers in the U.S.



PSWBC

- Opened in 2008 served 60 healthcare professionals
- Currently serving over 1,400 healthcare professionals
- 772 IENs (internationally educated nurses)
- 278 IMGs (international medical graduates)
 - 12 completed residency, 2 in WA State
 - 2 started residency in July 2019
 - o 2 received fellowships in 2019
- PSWB began working with all foreign trained professionals in 2017

The Definition of an IMG (FMG)

"The location of the medical school, not the citizenship of the physician, determines whether the graduate is an IMG"*

- U.S. IMG: U.S. citizen who completed medical school outside of the U.S.
- Non-U.S. IMG: No U.S. citizenship, completed medical school outside the U.S.
 - Immigrant, refugee, asylum (permanent residency in the U.S.)
 - Exchange Visitor Program Physicians J1 (temporary education visa)
 - H-1B visa (temporary employment visa with option for permanent residency)



- 278 IMGs (international medical graduates)
 - 12 completed residency, 2 in WA State
 - 2 started residency in July 2019
 - 2 received fellowships in 2019

Surveyed 223 IMG participants, received 30 responses



- 7 received residency interviews
- 12 are working in healthcare field (Nursing Assistant, Research Associate, Medical Case Manager
- 4 unemployed
- 4 returned to school RN, MPH, Respiratory Therapy
- 2 are in IT

93% said they are still interested in pursuing a U.S. medical license

"More practical medical equivalence"

"I am studying for step 1 and I am happy to hear that we may apply for a residency in WA"

"There are so many barriers to getting medical license to practice. Finally I decided to look for an alternative way to getting patients feel better, having them feel cared for with satisfactory outcome."
